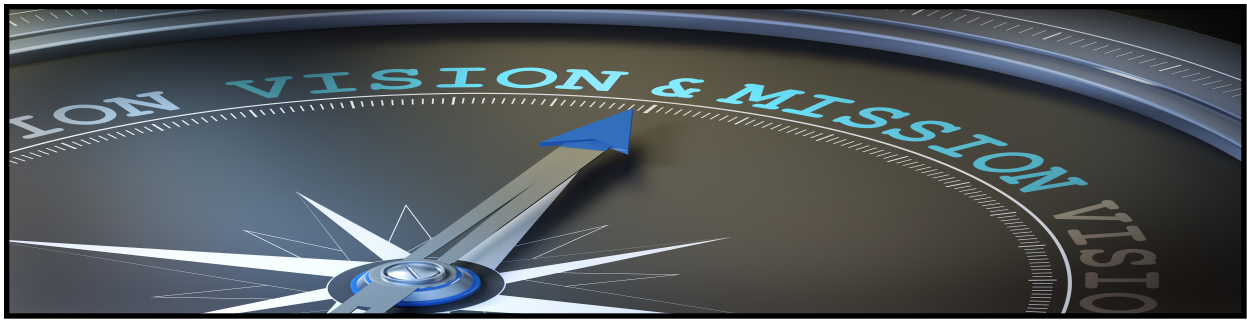
Founder
